Presentation of Minutes Eric Fedowitz

## Treasurer's Report

Cindy and Tony huddled and found we are in a space of a little breathing room. Tony then presented the following

Actions taken over the moth:

- Submitted new PPP loan application
- Nearly completed 2020 full year accounting

### Jan 2021 snapshot:

- Revenue down 26% compared to January 2020 close to worst-case scenario
- Operational expenses down slightly
- Month end cash balance \$258K
- Still waiting for forgiveness of first PPP loan

#### Looking forward:

- Continue to monitor financial picture
- May need to pass another Vestry resolution for re-authorizing use of up to \$250K in Kingdom Campaign
- Considering an Easter match

John and Teri presented on "Why rebuild the Website?"

Briefly the communications team is recommending this. Why this should be considered:

- Long Term Investment to convey the Strategic Plan
- How parishioners find information

Reasons why are Platform security, Users making content updates & Content moving to an active modern user-friendly site.

Last built in 2015 for \$22,200 by a graphic design firm, rather than a web developer firm, and since we have had no action plan or professional guidance.

Security issues: outdated WordPress theme and software plugins, unable to apply updates. This introduces risk that must be addressed. Attacked 3 years ago and recently 3 weeks ago. Crashes occur periodically. Fixes have been implemented, but this is not enough.

Major edits are time consuming, design issues are that we have too many pages, slow to render, cannot use on mobile devices.

Fix recommended would rebuild from ground up, minimize plugins, apply security best practices.

Proposals sought and came up with three.

- Cherix \$2,100 > foreign based, not mush support
- CWD \$11,750 > balance of pros/cons
- Peak Performance Digital \$12,970 recommended > thorough, John doesn't like the other two

The 2015 fee was branding and website development. So there was branding then that is not needed now.

We can limp along John explained, and we have a good firewall in place. Lori brought up security, Mark asked about hacks, Cynthia commented on security and access alternatives.

Teri focused on the inability to do software updates. The last one a couple weeks ago crashed the site. It was thought that the site may not be able to come back up.

Phoebe proposed funding come out of Kingdom Campaign, Catherine agreed. Question raised how long it would take to roll out -2 to 3-month endeavor. Cindy asked what is requested of the Vestry. Todd agreed Kingdom would be appropriate use.

Rip recommended up to \$15K to come out of Kingdom Campaign, seconded by Eric. Ft Ed suggested Lori and Eric be involved as they have both been involved in website development. Any discussion – none. Unanimous approval.

Ft. Ed noted both wardens are leaving after this year, and Catherine and Rip are rotating out. Problem is Catherine is not local, Rip is busy, and Cindy & Charles is running things, which leaves us with a need for 3 to get to the 5 count for the nominating committee. Need to notify the congregation for voting notification. The four will speak among themselves to determine which of them will fill the need for three.
