1. What were the primary opportunities, innovations and challenges in conducting worship during the pandemic? What did you learn?

God is good! We were able to reach people through online services in ways that we never had before, including those who do not live near the church (or DC for that matter). We are so grateful for the high-definition cameras, as well as for smartphones and imovie which we used for recording and editing. Clergy/ministry leaders became audio-visual engineers and recording "artists" overnight. It was challenging, though, to not have a physical congregation.

2. What are the primary opportunities and challenges your church is facing as it plans for the future?

All Saints strives to serve our parishioners and help them grow in faith. In some ways, Zoom helps this happen. In other ways, we realize how valuable it is to share a meal, or just be together. We have experienced opportunities for reaching folks we might never have before and showcasing our worship services online so folks can "experience" it before, hopefully, attending. But, it will be challenging to get a full house back with confidence and enthusiasm for being back together as a congregation versus remaining home because all our services/ministries will have an online presence. We will need to continue to shift our understanding of online worship as a new and legitimate part of our ongoing ministry.

3. What three things have changed the most in how the church conducts its ministry?

1. Our expanded use of technology for both parishioner and staff interaction, including our Realm database and Constant Contact email platform, Zoom, YouTube, emails, phone, and texting
2. Pastoral connections and intentional caring for one another, including coordinated efforts to call parishioners through the visiting ministry team
3. A winsome, yet honest, approach to stewardship, asking and thanking people as they give to All Saints
