#### **Key Assumptions:**

- \$1.4M pledged income
- \$100K of new money from pledges
- \$580K non-pledged contributions
- \$150K Preschool budget surplus
- 10% from Music Fund of approximately \$70K
- \$100K from Endowment Fund
- \$20K from Thrift Shop
- \$5K in Facility Use Fees from weddings and other events outside of regular business hours (conservatively based on last year's income)
- \$80K from Kingdom Funds to cover Kingdom and strategic initiatives in Student Ministry
- An additional \$500K, or more, may be realized from the Employee Retention Credit grant, but this is not included in the budgeted Income



#### **Key Assumptions:**

- 2023 expenses were calculated on 2021 actual expenses and 2022 projected expenses
- Building and Grounds has no new budgeted funds for non-discretionary building projects—only maintenance and repairs; however, funds designated and raised in prior years will fund the Great Hall renovation project in Summer 2023
- Three current staff members will not serve ASC in 2023: Mac Stewart, LaJeune Small, and Glenn Jahnsen
  - o Zacher Bayonne has been asked to serve as a stipendiary clergy to help with preaching and teaching
  - Prager Metis will take on the parish accountant's duties; budgeted amount for Prager-Metis was increased by \$30K
  - Occasional church meals will be catered
- A new copier contract will be finalized to save \$20K
- Musicians for special services, including Easter and Christmas, will be funded through special donations
- Altar flowers will be funded entirely from special donations
- The Diocesan Pledge is set at \$50K with the understanding that it may be increased when/if we receive ERC grant

GATHER\_\_\_\_\_\$80,800

We GATHER our parish in faith in Jesus Christ at Sunday worship and other special services, in fellowship over coffee and meals, and in friendship through groups based on shared interests. We seek and welcome new people to our church.

In worship, we gather as a community of faith, where we celebrate God's presence and respond to God's call to service in our world. Our ministry personnel, working with our Minister of Music and Communications Team, prepare the weekly worship services and bulletins. We have a strong tradition of involving lay members in leadership in our worship. We offer worship each week on Sundays with a service at 8:30 a.m. and two services at 10:30 a.m.

- Children's worship services on Sunday during adult worship and on Wednesday for Preschool students
- Annual visit from Bishop Little
- Funerals, weddings, baptisms, and records

- Volunteer recruitment, retention, and recognition
- Regular publication of our parish newsletter and weekly eblast

GROW \$16,300

We GROW individually and as a parish by offering Christian education and other spiritual formation opportunities for parishioners at every stage of their journey as Christians.

We provide education for children and youth, preschool – Grade 12, each Sunday morning. Youth group gatherings encourage teenagers to spend time in fellowship, spiritual growth, and service. Adult education classes are held on Sunday mornings and Bible studies, throughout the week. Special classes throughout the year bring together adults who want to become members and reaffirm their baptismal vows, parents who want to have their children baptized or to receive first Communion, and teenagers who want to reaffirm their baptismal vows through Confirmation.

As people of God, we are called to work in the world around us. We provide time and money for God's work beyond our church walls This work takes place in Chevy Chase, Washington, DC, in the US, and in countries all around the world.

Throughout the year, we reach out beyond this budget and provide additional support and funding to special projects as needs are identified.

We respond to individuals in times of crisis, such as illness or bereavement. We keep in touch with members who are unable to come to church. Our ministry personnel and volunteer visitors want to make this church a caring community where each person is able to feel the love of God being shared with one another.

Our building and grounds continue to support our active congregation in their quest to live out Christ's Great Commission to "go and make disciples."

#### **Diocesan Pledge**

\$50,000
