



### **Vestry Housing Allowance Resolution**

The following resolution was duly adopted by the vestry of All Saints Church at the regularly scheduled meeting held on January 24, 2023, a quorum being present:

Whereas, Section 107 of the Internal Revenue Code permits a minister of the gospel to exclude from gross income a church-designated allowance paid to him as part of his compensation to the extent used by him for actual expenses in owning or renting a home; and

Whereas, Matthew W. Kozlowski is compensated by All Saints Parish exclusively for services as a minister of the gospel; and

Whereas, All Saints Parish does not provide Fr. Kozlowski with a rectory, therefore, it is hereby

Resolved, that the designation of \$5,000 (five thousand dollars and zero cents) per month for a total of \$60,000 (sixty thousand dollars and zero cents) per annum of the Priest's annual compensation for 2023 is hereby designated as a housing allowance.

Said allowance amount shall apply to calendar year 2023 and all future years unless otherwise provided by the vestry.

Whereas, Section 107 of the Internal Revenue Code permits a minister of the gospel to exclude from gross income a church-designated allowance paid to him as part of his compensation to the extent used by him for actual expenses in owning or renting a home; and

Whereas, William Buracker is compensated by All Saints Parish exclusively for services as a minister of the gospel; and

Whereas, All Saint's Parish does provide Fr. Buracker with a rectory and pays the sum of \$25,800 (twenty-five thousand eight, hundred dollars and zero cents) per annum, therefore, it is hereby

Resolved, that the annual compensation paid to William Buracker for calendar year 2023 shall be in addition to the above stipulated rental fees for said rectory an additional \$416.67 (four hundred sixteen and sixty-seven cents) per month for a total of \$5,000.04 (five thousand and four cents) per annum of his total compensation for 2023 is hereby designated to be a housing allowance pursuant to Section 107 of the Internal Revenue Code and it is further resolved that:

Said allowance amount shall apply to calendar year 2023 and all future years unless otherwise provided by the vestry.

Whereas, Section 107 of the Internal Revenue Code permits a minister of the gospel to exclude from gross income a church-designated allowance paid to him as part of his compensation to the extent used by him for actual expenses in owning or renting a home; and

Whereas, Gary Wieder is compensated by All Saints Parish exclusively for services as a minister of the gospel; and

Whereas, All Saint's Parish does provide Gary Wieder with a rectory therefore, it is hereby

Resolved, that the annual compensation paid to Gary Wieder for calendar year 2023 shall be in addition to the above stipulated housing an additional \$1,300 (one thousand, three hundred dollars and zero cents) per month for a total of \$15,600 (fifteen thousand, six hundred dollars and zero cents) of his total compensation is hereby designated to be a housing allowance pursuant to Section 107 of the Internal Revenue Code and it is further resolved that:

Said allowance amount shall apply to calendar year 2023 and all future years unless otherwise provided by the vestry.
